Dear Parents:

The Cumberland Middle School will be offering an 8<sup>th</sup> grade field trip to Six Flags Over Texas Amusement Park, in Arlington, Texas on May 20<sup>th</sup>. This will be the end of the year celebration for the 8<sup>th</sup> grade students. We would like all students to be able to attend. Tickets into the park will be \$53 per student payable to CAMS. This price will include admission into the park, one meal voucher, one snack voucher and one all-day drink bottle. **Your son or daughter will need to pay for their individual ticket by April 29<sup>th</sup> to ensure a seat on the bus.** Please complete the attached permission form for the trip if you approve of your child attending this event.

We will depart from school at 8:30 am and will return around 7:00 pm. We will have your child call 30 minutes prior to arrival at school, in order for him/her to be picked up. Each student will be provided a ticket, which will allow them entry into the park and the option to participate in most activities and rides at the park. Anyone wanting to buy a Fast-Pass, will do so at their own expense. Any additional money for games and activities not covered by the park pass must be provided by the student.

Your child's ticket will be held by an adult supervisor until the students are ready to enter the park, at which time, the supervisor will give the tickets to the park employee for admittance. Students will be in groups and must travel with a supervisor throughout the day. It would be wise to send your child with sunscreen that they may apply to their skin during the daily activities.

Parents: please understand that by signing this form you will be **giving permission for your son/daughter to participate in all activities** at Six Flags and **ride all the rides offered at the park**, unless restricted by the Six Flags personnel because of size requirements for each ride. Teachers will not be required to judge whether a student is eligible to participate on any ride. If you do not give permission for your child to participate on all rides and activities provided by the park, your child will not be able to attend the field trip.
